Fiscal Year 2019-2020

Our Services

Outpatient Drug and Alcohol Services:

- Capacities: 249 Outpatient, 215 Intensive Outpatient Treatment, 53 Partial Hospital, 214 Erie County Prison Program
- Outpatient Treatment, Intensive Outpatient, Partial Hospitalization Programming, and Level of Care assessments
- Medication Assisted Treatment: Vivitrol
- Staffing: Clinical Director, Clinical Supervisor, 9 full time counselors, part time art therapist, RN, CRNP, 1 full time receptionist, 1 part time receptionist

Outpatient Drug and Alcohol Services at the Erie County Prison:

- Provide licensed outpatient drug and alcohol treatment and Vivitrol services within the Erie County Prison
- Coordinate aftercare services or individuals being released into the community
- Staffing: 3 full time counselors, 1 full time LPN, part time CRNP

Gage House:

- 15 bed co-ed dual licensed residential program focusing on the treatment of individuals with co-occurring substance abuse and mental health disorders
- 658 admissions
- Offering short term and long term treatment stays
- Staffing: Clinical Supervisor, Program Manager, 4 full time clinical staff, 1 part time counselor, 1 full time RN, 1 full time LPN, part time psychiatrist, 1 Certified Recovery Specialist, 4 full time residential aides and 8 part time aides

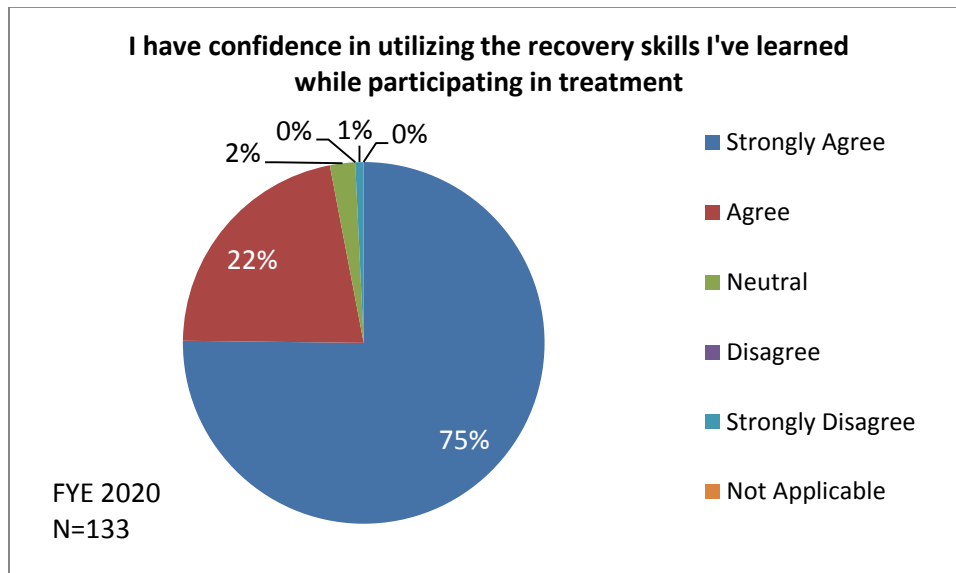
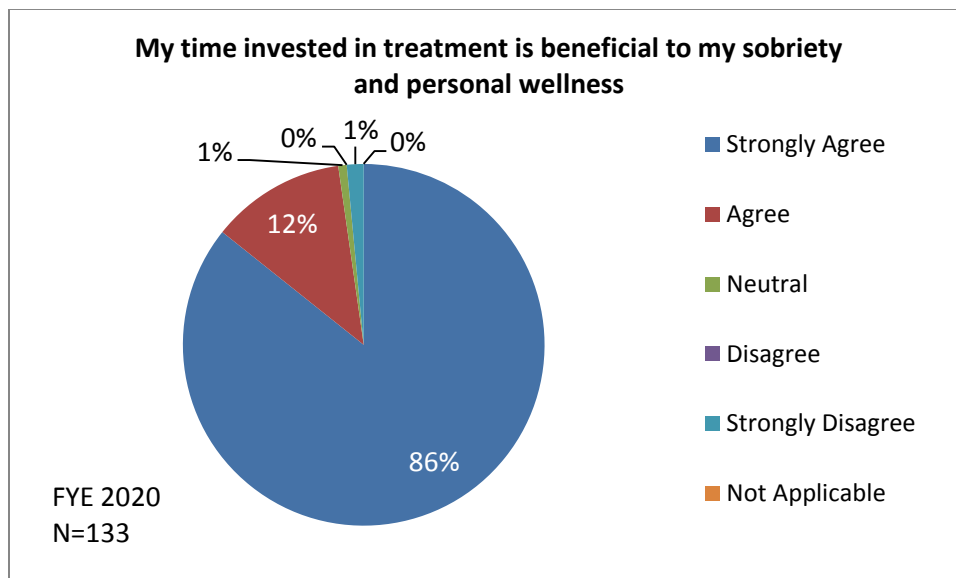
Certified Recovery Specialist Services:

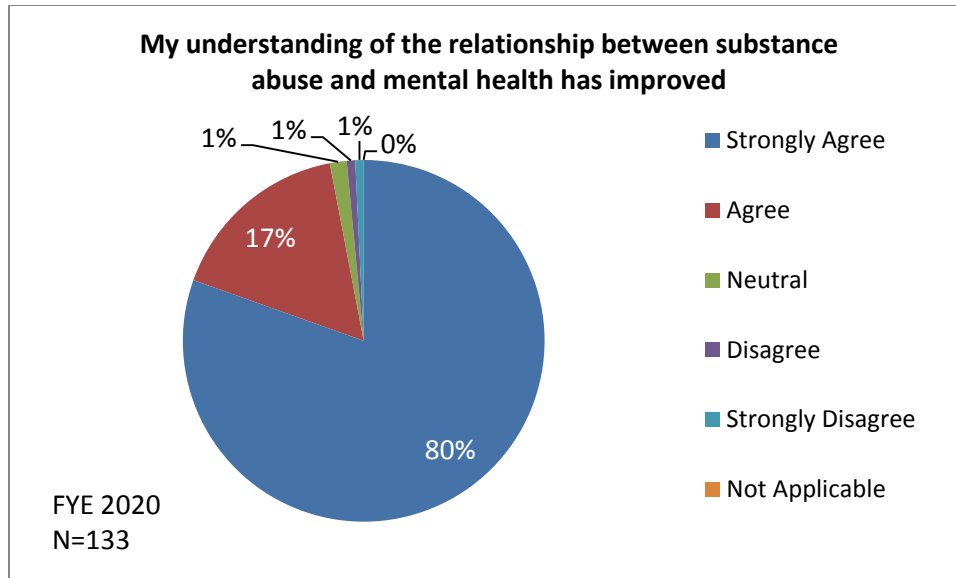
- Providing community based support to individuals with substance abuse needs at any stage of the recovery process
- Staffing: Clinical Supervisor, 2 full time CRS, 1 part time CRS

- Expanded use of telehealth and video services into all aspects of the treatment process
- Remained open throughout the entirety of the COVID-19 pandemic
- Provided education and referrals to COVID-19 testing and vaccination sites, providing face shields, masks, and other personal protective equipment to staff and clients
- Starting renovations to the Gage House program site
- Several team members obtained advanced degrees, licensure or PCR certification
